Installation Instructions

- . Directly connect the Adapter to the USB-C/Thunderbolt 3 port of the host
- Connect an HDMI or VGA cable to the Adapter (only 1 display is supported)
- . Select the HDMI or VGA input from the display menu
- · Find a compatible video resolution between the host and output display
- · Note: 4K video resolution support requires a 4K computer source and output display

Troubleshooting Tips

- . DisplayPort Alternate Mode (video over USB) must be supported by your device
- . Test the Adapter with a different USB-C/Thunderbolt 3 port
- . Test the HDMI or VGA cable with other equipment
- VGA does not support audio or HDCP for viewing protected content
