Installation Instructions

- . Connect the adapter directly to the USB-C/Thunderbolt 3 port of the host
- . Connect an HDMI cable (sold separately) in the shortest length needed
- . Find a compatible video resolution between the host and the output display
- Note: 4K video resolution requires a 4K source and 4K-rated HDMI cable

Troubleshooting Tips

- . DisplayPort Alt Mode (video over USB-C) must be supported by your device
- . Test with a different HDMI cable and output display
- . Try a different USB-C/Thunderbolt 3 port on your device
- Check for updated Thunderbolt 3 driver updates
