Installation Instructions

- 1) Connect the Adapter to a USB computer port and check that the blue LED is lit.
- 2) Connect an Ethernet patch cable to a router or LAN.
- 3) Check the documentation of your router to configure network access.

Notes: Green LED indicates a live network connection

Vellow LED indicates data transfer status

Troubleshooting Tips

- · Reboot your computer and router
- · Check that the LEDs are lit
- . Configure the Adapter with a static IP address, if required.
- · Test by turning off all wireless functions
- · Test the Ethernet patch cable with another computer
- . Try a different USB port or computer
- · Verify that your computer recognizes the Adapter:
